Education (Amendment No. 4) Regulations 2023

THE EDUCATION ACT

Regulations made by the Minister under section 38 of the Education Act

- 1. These regulations may be cited as the Education (Amendment No. 4) Regulations 2023.
- 2. In these regulations -

"principal regulations" means the Education Regulations 1957.

3. Regulation 2 of the principal regulations is amended by inserting, in the appropriate alphabetical order, the following new definitions –

"degree" means a degree in the subject to be taught from a recognised institution, as determined by the Higher Education Commission;

"equivalent qualification" means a qualification of the same level and in the same subject as required for the post, as determined by the Higher Education Commission;

- 4. Regulation 3 of the principal regulations is amended -
 - (a) in paragraph (1), by revoking subparagraph (b) and replacing it by the following subparagraph
 - (b) for the secondary school stage, in respect of a subject set out in the Third Schedule –
 - (i) (A) a Cambridge School Certificate with credit in at least 5 subjects including English Language obtained at not more than 2 sittings; or
 - (B) Passes not below Grade C in at least 5 subjects including English Language obtained at not more than 2 sittings at the General Certificate of Education "Ordinary Level",

provided that at one of the sittings, Passes have been obtained either -

- (I) in 5 subjects including English Language with at least Grade C in any 2 subjects; or
- (II) in 6 subjects, including English Language with at least Grade C in any one subject;
- (ii) a Cambridge Higher School Certificate or Passes in at least 2 subjects obtained on one certificate at the General Certificate of Education "Advanced Level";

- (iii) where credit is not obtained in English Language at the Cambridge School Certificate, Passes in at least 2 subjects at "Advanced Level" and at least 2 subjects at "Subsidiary level", including General Paper, obtained at one sitting at the Cambridge Higher School Certificate Examinations; and
- (iv) (A) (I) a degree or joint degree in the subject to be taught, or an equivalent qualification; and
 - (II) a Post Graduate Certificate in Education from a recognized institution, or an alternative qualification in Education from a recognised institution; or
 - (B) a B.Ed from the Mauritius Institute of Education in the subject to be taught;
- (v) for subjects set out in the Fourth Schedule, an educator shall teach that subject provided he holds
 - (A) qualifications as prescribed under sub subparagraphs (i) and (ii); and
 - (B) the required qualifications set out in the Fourth Schedule.
- (b) by inserting, after paragraph (1), the f6llowing new paragraphs –

(1A) Notwithstanding paragraph (1)(b), any person who holds any degree in any subject listed in the Third or Fourth Schedule and who is enrolled on a course leading to –

- (a) a PGCE; or
- (b) any alternative qualification in education from a recognised institution,

may teach in a temporary capacity for the years 2023 to 2026.

(1B) Notwithstanding paragraph (1)(b), any educator may, in the lower secondary grades, teach a subject in respect of which he holds a pass at "Advanced Level".

- **5.** The principal regulations are amended by revoking regulation 4A.
- **6.** The principal regulations are amended by adding the Third and Fourth Schedules set out in the First and Second Schedules to these regulations.
- **7.** These regulations shall not apply to any person who, before the coming into operation of these regulations, has been recruited to teach in a public or private secondary school.
- 8. These regulations shall come into operation on 1 March 2023.
