THE EXCISE ACT

Regulations made by the Minister under section 57 of the Excise Act

- 1. These regulations may be cited as the Excise (Amendment) Regulations 2014.
- **2.** In these regulations —

"principal regulations" means the Excise Regulations 1994.

- 3. The principal regulations are amended
 - (a) in regulation 2, in the definition of "certificate of conformity", by inserting, after the word "index", the words "or energy efficiency ratio or seasonal energy efficiency ratio";
 - (b) in regulation 27(3), by deleting the words "1, 2, 3 and 4" and replacing them by the words "1, 2, 3, 4 and 7";
 - (c) in Part VI, in the heading, by inserting, after the words "FORTIFIED FRUIT WINE,", the words "ISLAND WINE, FORTIFIED ISLAND WINE, ADMIXED WINE, FORTIFIED ADMIXED WINE, MADE WINE, FORTIFIED MADE WINE,";
 - (d) in regulations 34, 37, 39, 40(a) and 40(b), by inserting, after the words "fortified fruit wine,", the words "island wine, fortified island wine, admixed wine, fortified admixed wine, made wine, fortified made wine,";
 - (e) in regulation 35 —

- (i) in paragraph (a), by inserting, after the words "fruit wine", the words ", island wine, made wine, admixed wine and wine";
- (ii) in paragraph (b), by inserting
 - (A) after the words "fortified wine", the words ", fortified island wine, fortified admixed wine, fortified made wine";
 - (B) after the words "the wine", the words ", island wine, admixed wine, made wine";
- (f) in regulation 36, by inserting, after the words "fortified wine", the words ", fortified island wine, fortified admixed wine, fortified made wine";
- (g) in regulation 38, by inserting, after the words "fortified wine", the words ", fortified island wine, fortified admixed wine, fortified made wine";
- (h) in regulation 41, by inserting, after the words "fruit wine", the words ", island wine, made wine, admixed wine";
- (i) in regulations 88 and 89, by inserting, after the word "imported", the words "or purchased";
- (j) in regulations 90, 91 and 92, by deleting the word "imported" wherever it appears;
- (k) in regulation 93
 - (i) by inserting, after the words "liquor imported", the words "or purchased";
 - (ii) in paragraph (a), by inserting, after the words "of the importer", the words "or purchaser";
- (I) in regulation 94, by inserting, after the words "blend or mix imported", the words "or purchased";
- (m) in regulation 97, by deleting the figure "40" and replacing it by the figure "37";

- (n) in regulation 99B(1), by adding the words "issued by the Director-General under regulation 99C(3)";
- (o) in the First Schedule, by inserting, after item 6, the following new items and their corresponding entries —
