Electricity (Licensing, Registration and Fees) Regulations 2022

THE ELECTRICITY ACT 2005

Regulations made by the Minister after consultation with the Utility Regulatory Authority under section 44 of the Electricity Act 2005

- 1. These regulations may be cited as the **Electricity (Licensing, Registration and Fees) Regulations 2022.**
- 2. In these regulations —

"Act" means the Electricity Act 2005;

"certificate of exemption" means a certificate issued by the Authority to an exempt person;

"exempted activity" means an activity specified in the first column of Part I of the Schedule;

"exempt person" means a person who conducts or intends to conduct an exempted activity;

"online platform" means the Authority e-licensing platform found on its website.

- **3.** (1) Any person who intends to conduct an exempt activity shall make an application, in writing, to the Authority on the online platform and provide information as the Authority may require.
 - (2) Where the Authority grants the application under paragraph (1), it shall –

- (en) on payment of the corresponding fee specified in the second column of Part I of the Schedule; and
- (eo) on such terms and conditions as it may determine,

issue a certificate of exemption.

- **4.** (1) For the purpose of obtaining a project finance, testing plant reliability or developing a project, a person may, in respect of the activity specified in the first column of Part III of the Schedule, make an application to the Authority on the online platform for a provisional generation licence.
- (2) Where the Authority grants the licence, it shall, on payment by the licensee of the fee specified in the corresponding second column of Part III of the Schedule, issue a provisional generation licence.
- (3) (a) Where the licensee under this regulation intends to amend his activities specified in the provisional generation licence, he may make an application to the Authority on the online platform for an amended provisional generation licence and provide such information as the Authority may require.
- (b) The Authority may, on payment, by the licensee, of the fee specified in the corresponding third column of Part III of the Schedule, issue an amended provisional generation licence.
- (4) Where the licensee under this regulation intends to renew his provisional generation licence, he may make an application to the Authority on the online platform for the renewal of the provisional generation licence and provide such information as the Authority may require.
- (5) The Authority may, on payment, by the licensee, of the fee specified in the corresponding fourth column of Part III of the Schedule, renew the provisional generation licence.
- **5.** (1) (a) Every holder of a provisional generation licence specified in the first column of Part III of the Schedule shall, at least 90 days before starting the commercial

operation of a generating station, make an application to the Authority on the online platform for a permanent licence in respect of the activity specified in the first column of Part II of the Schedule and provide such information as the Authority may require.

- (b) The Authority may, on payment, by the applicant, of the fee specified in the corresponding second column of Part II of the Schedule, issue a permanent generation licence.
- (2) (a) Where a person has been issued with a transitional licence, he shall make an application to the Authority through the online platform, in respect of the activity specified in the first column of Part II of the Schedule, for a permanent licence and provide such information as the Authority may require.
- (b) The Authority may, on payment by the applicant of the fee specified in the second column of Part II of the Schedule, issue a permanent licence.
- (3) (a) Where the licensee under this regulation intends to transfer his licence in the name of another person, he may make an application to the Authority for a transfer of the licence and provide such information as the Authority may require.
- (b) The Authority may, on payment, by the licensee, of the fee specified in the corresponding third column of Part II of the Schedule, transfer the licence.
- (4) (a) Where the licensee under this regulation intends to amend his activities specified in the licence, he may make an application to the Authority for an amended licence and provide such information as the Authority may require.
- (b) The Authority may, on payment, by the licensee, of the fee specified in the corresponding fourth column of Part II of the Schedule, issue an amended licence.
- (5) (a) Where the licensee under this regulation intends to renew his licence, he may make an application to the Authority for the renewal of the licence and provide such information as the Authority may require.
- (b) The Authority may, on payment, by the licensee, of the fee specified in the corresponding fifth column of Part II of the Schedule, renew the licence.
