THE GAMBLING REGULATORY AUTHORITY ACT

Regulations made by the Minister under sections 88 and 164 of the Gambling Regulatory Authority Act

- 1. These regulations may be cited as the **Gambling Regulatory Authority (Government Lotteries) (Amendment) Regulations 2014**.
- 2. In these regulations —

"principal regulations" means the Gambling Regulatory Authority (Government Lotteries) Regulations 1992.

- 3. The principal regulations are amended in the Schedule
 - (a) by revoking paragraph 1 and replacing it by the following paragraph
 - 1. On the draw day referred to as "draw MI", lucky numbers attributable to sold lottery tickets and being the actual numbers of sold lottery tickets, will be drawn and will entitle the holders of the lottery tickets bearing the lucky numbers to participate in a lucky draw, to be held on the day of the next draw referred to as "draw M2".
 - (b) by inserting, after paragraph 1, the following new paragraph
 - **1A.** The Lottery Committee may determine the number of lucky numbers to be drawn for the purpose of paragraph 1.
