THE IRRIGATION AUTHORITY ACT

Regulations made by the Minister under sections 14 and 21 of the Irrigation Authority Act

1. These regulations may be cited as the **Irrigation Area (Declaration of Irrigation Area) Regulations 2014**.

2. In these regulations —

“Act” means the Irrigation Authority Act.

3. For the purposes of section 14 of the Act, the area specified in the Schedule shall be irrigation areas.

SCHEDULE

[Regulation 3]

ST FELIX LAMU SMALL SCALE IRRIGATION PROJECT

An area, including the delivery main, situate at St. Felix, in the district of Savanne of an extent of one hundred and fifteen hectares five thousand and five square metres (11 5ha5,005 m²) and is bounded as follows:-

Towards the North East —

From A to B, by the Martiniere Road (Chamouny Road B89), on a developed length measuring one thousand nine hundred and nine metres and eighty six centimetres (1,909.86 m).

Towards the South East —

From B to C, partly by the axis of a track road three metres (3.00 m) wide, on two straight lines of respective length, the first one of two hundred and eighty six metres and eighty four centimetres (286.84 m) and the second one of one hundred and ninety nine metres and fifty seven centimetres (199.57 m) and partly by Taleevun Gajadhur, partly by Kamalsaw Gajadhur and partly by Dropattee Gajadhur, on a total length of one hundred and fifty metres and eight centimetres (150.08 m).

Towards the South West —

From C to D, by the axis of a track road three metres (3.00 m) wide, on a developed length measuring nine hundred and eighty nine metres and thirty centimetres (989.30 m).

Towards the West —

From D to E, by the axis of a track road three metres (3.00 m) wide, on two developed lengths, the first one of one hundred and forty two metres and thirty six centimetres (142.36 m), the second one of four hundred and eight metres and ninety five centimetres (408.95 m) respectively.

From E to A, by the axis of a track road three metres (3.00 m) wide, on four lengths, the first one a developed length of five hundred metres and twenty seven centimetres (500.27 m), the second one, a straight length of ten metres and thirty four centimetres (10.34 m), the third one, a developed length of seven hundred and thirty three metres and fifty five centimetres (733.55 m) and the fourth one, a straight length of twenty three metres and fifty eight centimetres (23.58 m) respectively.

DESCRIPTION OF DELIVERY MAIN

The delivery main is located within a strip of land three metres (3.00 m) wide, linking the main Irrigation Zone to two Weirs, of a total extent of four thousand eight hundred and thirty

six square metres (4,836 m²) and bounded as follows —

Towards the North, by Weir A, on three metres (3.00 m),

Towards the East, partly by the reserves of 'Riviere Patates', on a developed length of one hundred and fifty five metres and seventy two centimetres (155.72 m), partly by a portion of land belonging to Abdool Salim Rossaye, on a developed length of thirty three metres and forty one centimetres (33.41 m), partly by a portion of land occupied by Mamode Rafick Hosanee, on two straight lengths of one hundred and twenty eight metres and sixty eight centimetres (128.68 m) and nine metres and seventy one centimetres (9.71 m) respectively, partly by a portion of land belonging to Hassenjee Jugon, on two straight lengths of three metres and eighty four centimetres (3.84 m) and forty five metres and seventy five centimetres (45.75 m), partly by a portion of land belonging to Daramduth Unnuth, on a developed length of one hundred and ninety five metres and eighty two centimeters (195.82 m), partly by a portion of land belonging to Abdool Fazleck Rossaye, on a developed length of one hundred and ninety five metres and twenty five centimetres (195.25 m), partly by a portion of land belonging to Ahmed Sabeer Keenoo, on a straight length of two metres and ninety three centimetres (2.93 m), partly by a portion of land belonging to Harryduth Sampath, on a developed length of one hundred and eighty eight metres and seventy seven centimetres (188.77 m), partly by La Martiniere Road (Chamouny Road B89), on nine lines of twenty five metres and fifty eight centimetres (25.58 m), one hundred and fifteen metres and thirty six centimetres (115.36 m), fifty metres and four centimetres (50.04 m), two hundred and eight metres and sixty two centimetres (208.62 m), thirty four metres and seven centimetres (34.07 m), thirty metres and seventeen centimetres (30.17 m), thirty seven metres and nine centimetres (37.09 m), fifty three metres and eleven centimetres (53.11 m) and thirty eight metres and fifty nine centimetres (38.59 m) respectively and partly by a portion of land belonging to Leelowtee Guzadhur, on thirteen metres and fifty four centimetres (13.54 m).

Towards the West, partly by a portion of land belonging to Atteeyanun Hardass, on three metres (3.00 m), partly by a portion of land belonging to Leelowtee Guzadhur, on two straight lines of respective length, twelve metres and fourteen centimetres (12.14 m) and thirty six metres and ten centimetres (36.10 m), partly by a portion of land belonging to Mantee Guzadhur, on fifty two metres and forty centimetres (52.40 m), partly by a portion of land

belonging to Jaynarain Guzadhur, on thirty six metres and seventy seven centimetres (36.77 m), partly by Ramprakash Guzadhur, on thirty metres and thirteen centimetres (30.13 m), partly by a portion of land belonging to Seetall Guzadhur, on thirty four metres (34.00 m), partly by a portion of land belonging to Gyandut Gujadhur, on twenty four metres and fifty seven centimetres (24.57 m), partly by Krishnah Ramsamy, on two straight lengths of one hundred and seventy five metres and thirty seven centimetres (175.37 m) and forty eight metres and seventy seven centimetres (48.77 m) respectively, partly by Surendra Dumur, on one hundred and seventeen metres and seventy centimetres (117.70 m), partly by La Martiniere Road (Chamouny Road B89), on twenty six metres and fifty six centimetres (26.56 m), partly by a portion of land belonging to Harryduth Sampath, on a developed length of one hundred and eighty nine metres and twenty five centimetres (189.25 m), partly by a portion of land belonging to Ahmed Sabeer Keenoo, on seven metres and forty two centimetres (7.42 m), partly by a portion of land belonging to Abdool Fazleck Rossaye, on a developed length of one hundred and ninety metres and forty two centimetres (190.42 m), partly by a portion of land belonging to Daramduth Unnuth, on a developed length of one hundred and ninety five metres and eighty centimetres (195.80 m), partly by a portion of land belonging to Hassenjee Jugon, on two straight lengths of forty six metres and ninety two centimetres (46.92 m) and four metres and ninety three centimetres (4.93 m) and partly by a portion of land belonging to Satyavrat Dookheet, on four lengths, the first two, straight lines of eight metres and fifty three centimetres (8.53 m) and ninety seven and five centimetres (97.05 m) and the last two, developed lengths of twenty four metres and sixteen centimetres (24.16 m) and one hundred and sixty two metres and thirty six centimetres (162.36 m).
