THE INDEPENDENT BROADCASTING AUTHORITY ACT

Regulations made by the Independent Broadcasting Authority, with the approval of the Minister, under section 38 of the Independent Broadcasting Authority Act

- 1.** These regulations may be cited as the **Independent Broadcasting Authority (Licence Fees) (Amendment No. 2) Regulations 2022**.
- 2.** In these regulations –
"principal regulations" means the Independent Broadcasting Authority (Licence Fees) Regulations 2002.
- 3.** The Schedule to the principal regulations is revoked and replaced by the Schedule set out in the Schedule to these regulations.
- 4.** (1) Parts I, II, III and IV of the Schedule shall be deemed to have come into operation on 1 June 2022.
(2) Part V of the Schedule shall be deemed to have come into operation on 29 August 2022.
