## THE INDEPENDENT BROADCASTING AUTHORITY ACT

Regulations made by the Independent Broadcasting Authority, with the approval of the Minister, under section 38 of the Independent Broadcasting Authority Act

- 1. These regulations may be cited as the **Independent Broadcasting Authority (Administrative Penalties) Regulations 2022**.
- 2. In these regulations –

"Act" means the Independent Broadcasting Authority Act;

"breach" means refraining to comply, or negligently failing to comply, with the Act or regulations made under the Act, Codes, any direction of the Authority or any conditions of a licence.

- **3.** (1) For the purpose of section 29 of the Act, where a licensee has committed a breach, the Authority shall, in determining the quantum of the administrative penalty to be imposed on the licensee, consider the following
  - (a) the nature and gravity of the breach;
  - (b) whether the licensee was aware of the breach;
  - (c) the measures or precautions which the licensee took to prevent the breach or to mitigate the impact thereof;
  - (d) the intent or negligence, if any, of the licensee in committing the breach;
  - (e) the duration, scheduling and frequency of the breach;
  - (f) the conduct of the licensee after it became aware of the breach;
  - (g) any element which serves to deter the licensee from committing the breach;
  - (h) any damage to the reputation of a person or an institution as a result of the breach;
  - (i) the previous disciplinary record and compliance history of the licensee, including
    - (i) whether the Authority had formerly required the implementation of remedial action by the licensee and the extent to which such action has been complied with; and
    - (ii) the general compliance history of the licensee, including any adverse findings, if any;
  - (j) whether the imposition of the administrative penalty may cause significant financial impairment to the licensee.

- (2) In ascertaining the conduct of the licensee under paragraph (1)(f), the Authority shall consider the following
  - (a) whether and when the breach was brought to the attention of the Authority;
  - (b) whether appropriate remedial action has been taken by the licensee in an efficient manner with respect to the breach;
  - (c) the degree of co-operation with the Authority during the investigation or inquiry of the Authority into the breach;
  - (d) the likelihood of recurrence of the same type of breach if no suitable action is taken; and
  - (e) the nature and extent of any false or inaccurate information provided, whether knowingly or inadvertently, which results in the Authority being misled by the licensee.
- (3) Where the imposition of an administrative penalty may cause significant financial impairment to a licensee, the Authority may reduce the quantum of the administrative penalty to mitigate the financial impairment of the licensee.
- 4. These regulations shall come into operation on 8 August 2022.
