THE IMMIGRATION ACT

Regulations made by the Minister under section 21 of the Immigration Act

1. These regulations may be cited as the **Immigration (Permits) (Prescribed Fees, Guarantees and Application Form) (Amendment) Regulations 2022**.
2. In these regulations -

"principal regulations" means the Immigration (Permits) (Prescribed Fees, Guarantees and Application Form) Regulations 2011.
3. The Schedule to the principal regulations is revoked and replaced by the Schedule set out in the Schedule to these regulations.
4. These regulations shall come into operation on 11 July 2022.
