MAURITIUS MARATHI CULTURAL CENTRE TRUST ACT

**Regulations made by the Minister under section 15(2) of the Mauritius Marathi Cultural
Centre Trust Act**

1. These regulations may be cited as the **Mauritius Marathi Cultural Centre Trust (Amendment of Schedule) Regulations 2016**.

2. In these regulations -

“Act” means the Mauritius Marathi Cultural Centre Trust Act.

3. The Schedule to the Act is amended -
