THE LOCAL GOVERNMENT ACT 2011

Regulations made by the Municipal Town Council of Curepipe under section 163 of the Local Government Act

- These regulations may be cited as the Municipal Town Council of Curepipe (Traffic Centre) Regulations 2014.
- 2. In these regulations —

"bus" means a motor vehicle having a seating capacity for 7 or more passengers and carrying passengers for hire or reward at separate rates, and for which a Public Service Vehicle (Bus) licence has been issued by the National Transport Authority;

"Council" means the Municipal Town Council of Curepipe;

"licence" means public service vehicle licence;

"officer" means any officer of the public health department or any officer appointed by the Council;

"owner" means —

- (a) a person or legal entity in whose name a vehicle is registered or where that person is dead or absent from Mauritius or the entity has ceased to operate or where the vehicle is not registered, the person or entity in physical possession of the vehicle;
- (b) in relation to a vehicle which is the subject of a hiring agreement or hire purchase

agreement, the person or entity in physical possession of the vehicle under the agreement;

"park" means keep a vehicle, whether occupied or not stationary for a period of time longer than is necessary for the taking up or setting down of passengers;

"parking area" means the area designated by the Council for parking within the traffic centre;

"receipt" means the receipt of payment issued to a bus owner by the Council's cash office of the respective local authority and in which are mentioned the date of payment, the amount of the fee paid and the period for which payment has been made, the name of the bus owner and the receipt number;

"traffic centre" means a place designated by the Council and specified in the First Schedule;

"traffic sign" —

- (a) means any object or device, whether fixed or portable, for conveying warnings, information, requirements, prohibitions, of any description prescribed or authorised under these regulations to the traffic;
- (b) includes any line or mark within a traffic centre for conveying the warnings, information, requirements, prohibitions or restrictions.
- **3.** (1) Every bus owner licensed by the National Transport Authority, who uses a traffic centre, shall pay to the Council a monthly fee of 500 rupees per bus, which shall be payable in advance and not later than the last working day of the preceding month.
- (2) Any bus owner who fails to pay the fee, within the period, specified under paragraph (1) shall be liable to pay the monthly fee together with a surcharge of 50 per cent of the fee for each unpaid month to the Council.
 - (3) A receipt shall be issued in respect of every monthly payment.

(6) Any bus owner who —	
(a) stops using a traffic centre;	
(b) changes a bus; or	
(c) transfers his Public Service Vehicle (Bus) licence,	
shall inform the Chief Executive of the Council, in writing, thereof within 15 days cessation, change or transfer.	of the
4. (1) The Council may by means of traffic signs within a traffic centre —	
(a) regulate traffic;

(2) The Council may, at any time, cause the level of emission of exhaust fumes fro bus within the traffic centre to be tested by the relevant authority.	m any
5. (1) Any person who, within a traffic centre —	
(a) causes any major repairs to be effected to any bus;	
(b) washes any bus;	

- (c) allows any spillage of fuel, oil or other liquid from any bus;
- (d) horns unnecessarily; (e) carry out any hawking activities,

shall commit an offence.

- (2) The officer of the Council shall draw the attention of the owners of any breach of the regulation. The officer shall issue a Notice of Intended Prosecutions in case of non-compliance of the provisions of these regulations.
- (3) The Officer shall have the power to prohibit access to the traffic centre of any bus not complying with these regulations.
- (4) Any person who contravenes these regulations shall commit an offence and shall, on conviction, be liable to a fine not exceeding 25,000 rupees.
- **6.** The Municipal Council of Curepipe (Traffic Centre) Regulations 2010 are revoked.
