THE NATIONAL PENSIONS ACT

Regulations made by the Minister, after consultation with the Board, under section 46 of the National Pensions Act

- 1. These regulations may be cited as the **National Pensions (Amendment of Schedules)**Regulations 2015.
- In these regulations —
 "Act" means the National Pensions Act.
- **3.** The Act is amended by repealing the First Schedule and replacing it by the First Schedule set out in the Schedule to these regulations.
- **4**. The Second Schedule to the Act is amended, in item 10, by deleting the figure "490" and replacing it by the figure "520".
- **5.** The Fifth Schedule to the Act is amended
 - (a) in paragraph (a), by deleting the figure "14,805" and replacing it by the figure "15,710";
 - (b) in paragraph (b), by deleting the figure "7,403" and replacing it by the figure "7,855";
 - (c) in paragraph (c), by deleting the figure "6,833" and replacing it by the figure "7,251";
 - (d) in paragraph (d), by deleting the figure "3,417" and replacing it by the figure "3,625";
 - (e) in paragraph (e), by deleting the figure "569" and replacing it by the figure "604"; and

- (f) in paragraph (O~ by deleting the figure "569" and replacing it by the figure "604".
- 6. These regulations shall be deemed to have come into operation on 1 January 2015.
