

**Rodrigues Consumer Protection (Control of Price of Taxable and Non-Taxable Goods) (Amendment No. 15) Regulations 2015**

**THE CONSUMER PROTECTION (PRICE AND SUPPLIES CONTROL) ACT**

**Regulations made by the Minister under sections 3 and 35 of the Consumer Protection (Price and Supplies Control) Act**

1. These regulations may be cited as the **Rodrigues Consumer Protection (Control of Price of Taxable and Non-Taxable Goods) (Amendment No. 15) Regulations 2015**.

2. In these regulations —  
“principal regulations” means the Rodrigues Consumer Protection (Control of Price of Taxable and Non-Taxable Goods) Regulations 1998.
