Regulations made by the Minister under sections 3 and 35 of the Consumer Protection (Price and Supplies Control) Act

- 1. These regulations may be cited as the Rodrigues Consumer Protection (Control of Price of Taxable and Non-taxable Goods) (Amendment No. 15) Regulations 2024.
