**THE CONSUMER PROTECTION  
(PRICE AND SUPPLIES CONTROL) ACT**

**Regulations made by the Minister under sections 3 and 35 of the Consumer Protection (Price and Supplies Control) Act**

1. These regulations may be cited as the **Rodrigues Consumer Protection (Control of Price of Taxable and Non-taxable Goods) (Amendment No. 20) Regulations 2014**.

2. In these regulations —

“principal regulations” means the Rodrigues Consumer Protection (Control of Price of Taxable and Non-taxable Goods) Regulations 1998.

3. The First Schedule to the principal regulations is amended by inserting, in the appropriate alphabetical order, the following items and their corresponding entries —
