THE CONSUMER PROTECTION (PRICE AND SUPPLIES CONTROL) ACT

Regulations made by the Minister under sections 3 and 35 of the Consumer Protection (Price and Supplies Control) Act

- 1. These regulations may be cited as the Rodrigues Consumer Protection (Control of Price of Taxable and Non-Taxable Goods) (Amendment No. 26) Regulations 2015.**
- 2. In these regulations —**
“principal regulations” means the Rodrigues Consumer Protection (Control of Price of Taxable and Non-Taxable Goods) Regulations 1998.
