**Regulations made by the Minister under sections 3 and 35 of the Consumer Protection (Price  
and Supplies Control) Act**

1. These regulations may be cited as the **Rodrigues Consumer Protection (Control of Price of Taxable and Non-taxable Goods) (Amendment No. 33) Regulations 2022**.
2. In these regulations –  
  
"principal regulations" means the Rodrigues Consumer Protection (Control of Price of Taxable and Non-taxable Goods) Regulations 1998.
