

Rodrigues Consumer Protection (Control of Price of Taxable and Non-taxable Goods) (Amendment No. 40) Regulations 2014

THE CONSUMER PROTECTION (PRICE AND SUPPLIES CONTROL) ACT

Regulations made by the Minister under sections 3 and 35 of the Consumer Protection (Price and Supplies Control) Act

1. These regulations may be cited as the Rodrigues Consumer Protection (Control of Price of Taxable and Non-taxable Goods) (Amendment No. 40) Regulations 2014.
2. In these regulations —
“principal regulations” means the Rodrigues Consumer Protection (Control of Price of Taxable and Non-taxable Goods) Regulations 1998.
