## **THE REFORM INSTITUTIONS ACT**

### **Regulations made by the Minister under section 66 of the Reform Institutions Act**

- 1.** These regulations may be cited as the **Reform Institutions (Premises) (Amendment) Regulations 2014**.
- 2.** In these regulations —  
“principal regulations” means the Reform Institutions (Premises) Regulations 1995.
- 3.** The principal regulations are amended, in the First Schedule, in Part A, by adding the item specified in the Schedule to these regulations.

## **SCHEDULE**

[Regulation 3]

### **8. Eastern High Security Prison**

Portion No. 1 [PIN 1815120272]

A portion of State Land of the extent of fifteen hectares nine thousand two hundred and twenty-six and nineteen hundredths square metres (15Ha 9, 226.19m<sup>2</sup>), situated at Melrose in the District of Moka and bounded as follows —

Towards the North by an Estate Road four metres and seventy-five centimetres (4.75m) wide on which Government has a right of way on 3 lines measuring nine metres and fifty centimetres (9.50m), four hundred and twelve metres and eighty centimetres, (412.80m) and twenty-two metres and forty centimetres (22.40m), respectively.

Towards the East by a road reserve two metres and seventy-one centimetres (2.71m) wide bordering Montague Blanche - Bel Air — Road B27 on a total developed length of three hundred and seventy-seven metres and seven centimetres (377.07m).

Towards the South by sundry owners on a total length of six hundred and ninety-eight metres and sixty-five centimetres (698.65m).

Towards the West by an Estate Road five metres (5m) wide on which Government has a right of way on a total length of two hundred and eighty-three metres and forty-five centimetres (283.45m).

Portion No. 2 [PIN 1815120273]

A portion of the extent of twenty-one thousand one hundred and four square metres (21,104m<sup>2</sup>) and bounded as follows —

Towards the North by an Estate Road three metres and ninety centimetres (3.90m) wide on 2 lines measuring one hundred and eighty-three metres and eighty centimeters (183.80m)

and ten metres and eleven centimetres (10.11m) on a developed length, respectively.

Towards the East by an Estate Road five metres (5m) wide on which Government has a right of way on ninety-five metres and thirty-nine centimetres (95.39m).

Towards the South by an Estate Road three metres and ninety centimetres (3.90m) wide on 2 lines measuring seventeen metres and thirty-nine centimetres (17.39m) on a developed length and one hundred and eighty-two metres and two centimetres (182.02m), respectively.

Towards the West by surplus of land belonging to Alteo Ltd (ex-F.U.E.L) on one hundred and ten metres and fifty centimetres (110.50m).

There exist 2 declared buffer zones covering a distance of fifty metres (50m) outward the prison sites and running parallel to the site boundaries and a second one which extends one hundred metres (100m) parallel from the first buffer zone.

Government shall have a right of way along the Estate Road five metres (5m) wide and the Estate Road four metres and seventy-five centimetres (4.75m) wide situated at West side and North side of Portion No. 1 starting from the point having coordinates 255699.30mE, 351352.67mN through the points bearing coordinates 255652.10mE, 351638.49mN and 256059.09mE, 351707.64mN and ending at the point bearing coordinates 256080.83mE, 351702.24mN to access Montage Blanche - Bel Air Road (B27).
