

# Road Traffic (Speed) (Amendment) Regulations 2022

## THE ROAD TRAFFIC ACT

### Regulations made by the Minister under section 190 of the Road Traffic Act

1. These regulations may be cited as the **Road Traffic (Speed) (Amendment) Regulations 2022**.
2. In these regulations —  
"principal regulations" means the Road Traffic (Speed) Regulations 2011.
3. Regulation 2 of the principal regulations is amended —
  - (a) by deleting the definition of "UR road" and replacing it by the following new definition —  
""UR" road" means an urban or rural road, found within the boundaries of a city, town or village, which is not classified as a motorway or main road pursuant to the Motorways and Main Roads Regulations 1976.
  - (b) by inserting, in the appropriate alphabetical order, the following new definitions —  
"C road" means a "UR" road, other than a street, on which the speed limit is 40 kilometres per hour and which connects with roads classified as an "A" road, "B" road, or "M" road;  
  
"maximum speed limit" means the maximum authorised speed at which a motor vehicle specified in the first column of the Schedule may be driven on an "A road", a "B road", "M road" or an "UR road";  
  
"speed limit" means the speed limit indicated on a speed limit sign posted on the roadside;  
  
"street" means an "UR" road, other than a "C" road, with substantial abutting buildings, where pedestrians mostly interact with motorised traffic and on which the posted speed limit is 30 kilometres per hour;
4. Regulation 3 of the principal regulations is revoked and replaced by the following regulation —

**3.** Subject to these regulations, no person shall drive a motor vehicle specified in the first column of the Schedule on a road specified in the second, third, fourth, fifth or sixth column of that Schedule at a speed exceeding the corresponding maximum speed limit specified in the second, third, fourth, fifth or sixth column of that Schedule, as the case may be.

- 5.** The Schedule to the principal regulations is revoked and replaced by the Schedule set out in the Schedule to these regulations.
- 6.** These regulations shall come into operation on 15 March 2022.
