THE SOCIAL AID ACT

Regulations made by the Minister under section 11 of the Social Aid Act

- These regulations may be cited as the Social Aid (Amendment of Schedule) Regulations 2022.
- 2. In these regulations -

"Act" means the Social Aid Act.

- 3. The First Schedule to the Act is amended -
 - (a) in Part I, in items 1, 2, 3(a), (b), (c), (d), (e) and (f), 4, 5, and 10, by deleting the figures "1,527", "1,527", "594", "570", "699", "872", "1,527", "872", "906", "1,121", and "10,300" and replacing them by the figures "1,832", "1,832", "713", "713, "839", "1,046", "1,832", "1,046", "1087", "1,087", "1,345", and "12,360", respectively;
 - (b) in Part II, by deleting the figure "1,086" and replacing it by the figure "1,303";
 - (c) in Part III, in items 1, 2(a), (b), (c), (d), (e) and (f), 3, 4 and 9, by deleting the figures "1,597", "622", "599", "728", "914", "1,597", "739", "953", "1,178" and "10,300" and replacing them by the figures "1,916", "746", "746", "874", "1,097", "1,916", "887", "1,144", "1,414" and "12,360", respectively.
- **4.** The Third Schedule to the Act is repealed and replaced by the Third Schedule set out in the Schedule to these regulations.
- **5.** These regulations shall be deemed to have come into operation on 1 July 2022.
