

# **Seeds (Registration of Seed Dealer and Seed Producer) Regulations 2022**

**GN No. 227 of 2022**

**Government Gazette of Mauritius No. 117 of 27 August 2022**

## **THE SEEDS ACT**

**Regulations made by the Minister, after consultation with the National Plant Varieties and Seeds Committee, under sections 12, 22 and 33 of the Seeds Act**

### **1. Short title**

These regulations may be cited as the **Seeds (Registration of Seed Dealer and Seed Producer) Regulations 2022**.

### **2. Interpretation**

In these regulations -

“Act” means the Seeds Act;

“applicant” means a person who makes an application to register as a seed dealer or seed producer under regulation 5.

### **3. Application of regulations**

(1) These regulations shall apply only to a person who handles or produces seeds for commercial purposes.

(2) For the purpose of section 12 of the Act, every person who trades in, exports or imports any seed shall be registered as a seed dealer.

(3) For the purpose of section 22, registration as a seed producer shall not be compulsory unless, in the case of a crop that is grown on contract, such registration is required by the owner of the crop.

### **4. Guidelines**

NPVSO shall prepare and publish guidelines in relation to the procedures for registration as seed dealers and seed producers.

### **5. Application for registration as seed dealer or seed producer**

(1) A person who wishes to be registered as a seed dealer or seed producer, as the case may be, shall make an application to NPVSO in the form set out in the First or Second Schedule, as applicable.

(2) On receipt of an application made under paragraph (1), NPVSO shall -

- (a) send a written confirmation of receipt of the application to the applicant;
- (b) examine the application to confirm whether the requirements specified in the First or Second Schedule, as the case may be, have been complied with;
- (c) in case of any omission in the application form, contact the applicant promptly to obtain the necessary information or documentation;
- (d) undertake such investigations and inspections as may be required to confirm any information provided by the applicant.

## **6. Grant or refusal of application**

(1) Where NPVSO is satisfied that the application form is complete and all information provided is correct, NPVSO shall -

- (a) inform the Seeds Committee that it intends to issue a certificate of registration to the applicant; or
- (b) indicate any concerns that may affect the issue of such a certificate and request advice from the Seeds Committee.

(2) Where NPVSO grants an application under paragraph (1), it shall, on payment of the appropriate fee specified in the Third Schedule and on such terms and conditions as it may determine, register the applicant for a period of 3 years as -

- (a) a seed dealer and issue a certificate of registration in the form set out in the Fourth Schedule; or
- (b) a seed producer and issue a certificate of registration in the form set out in the Fifth Schedule.

(3) NPVSO shall, as soon as it issues a certificate of registration, enter such particulars in a register of seed dealers or seed producers, in accordance with section 12(6) or 22(4) of the Act, as the case may be.

(4) A seed dealer shall display the certificate of registration in a prominent place within the principal place of business.

(5) (a) Where NPVSO rejects an application under paragraph (1), it shall, within 10 days of its decision, inform the applicant in writing, stating the reasons for the rejection.

(b) Where the applicant is aggrieved by the decision of NPVSO, he shall, within 30 days of receipt of the decision, make an appeal to the Minister in accordance with the Seeds (Appeal Board) Regulations 2022.

## **7. Obligations of registered seed dealers**

A registered seed dealer shall -

- (a) keep adequate records of the seed lots he holds, including the source of seed, the date of acquisition and documents confirming the quality status of the seed lots intended for sale; and
- (b) upon request by an official inspector or sampler, grant access to the company premises so that records of seed lots can be inspected and samples taken, as the case may be.

## **8. Obligations of registered seed producers**

A registered seed producer shall -

- (a) keep adequate records of the seed crops that are grown and be able to demonstrate traceability through the production process;
- (b) comply with any technical guidelines relating to the production of the seed crop;
- (c) ensure that all harvested seed crops are stored in secure and clearly labelled containers while they are in premises of the producer; and
- (d) upon request by an official inspector or sampler, grant access to the fields or premises so that seed crops or seed lots can be inspected and samples taken, as the case may be.

## **9. Cancellation or suspension of registration**

(1) NPVSO may —

- (a) pursuant to section 12(7) of the Act, suspend or cancel the registration of a seed dealer; or
- (b) pursuant to section 23 of the Act, suspend or cancel the registration of a seed producer.

(2) No such cancellation or suspension shall be made unless the holder of the registration certificate has been given a reasonable opportunity of being heard in respect of the grounds of such cancellation or suspension, as the case may be.

(3) (a) NPVSO shall, within 30 days of any decision made under paragraph (1), inform the holder of the certificate in writing, stating the reasons for the suspension or cancellation.

(b) Where the holder of the certificate is aggrieved by the decision of NPVSO, he shall, within 30 days of receipt of the decision, make an appeal to the Minister in accordance with the Seeds (Appeal Board) Regulations 2022.

## **10. Renewal of registration**

(1) An application for the renewal of a certificate of registration issued under these regulations shall be made by the holder of the certificate in the form set out in the First or Second Schedule, as applicable, not later than 3 months before the date of its expiry.

(2) NPVSO may renew a certificate of registration on payment of the appropriate renewal fee specified in the Third Schedule and on such other terms and conditions as it may determine.

## **11. Right of inspection**

Pursuant to sections 17 to 20 of the Act, NPVSO may inspect the premises of a seed dealer or seed producer to ensure that the terms and conditions of registration and these regulations are being complied with.

## **12. Transitional provisions**

Any person who, at the coming into operation of these regulations, acts as a seed dealer, shall within 12 months from the coming into operation of these regulations, make an application to NPVSO to be registered as such under these regulations.

## **13. Offences**

Any person who contravenes these regulations shall commit an offence and shall, on conviction, be liable to a fine not exceeding 10,000 rupees or to imprisonment for a term not exceeding 6 months.

## **14. Commencement**

These regulations shall come into operation on 1 September 2022.
