## **The Tourism Authority Act**

#### Regulations made by the Minister under section 129 of the Tourism Authority Act

- These regulations may be cited as the Tourism Authority (Tourist Enterprise Licence
   Fees and Operating Fees) Regulations 2015.
- 2. In these regulations —

"Act" means the Tourism Authority Act.

- 3. For the purpose of section 25A(3) of the Act, the fee for the application for
  - (a) a tourist accommodation certificate shall be as specified in item 2;
  - (b) the variation of the terms of a tourist accommodation certificate shall be as specified in item 4,

of the First Schedule.

- **4.** For the purpose of section 26(3) and (5) of the Act, the fee for
  - (a) the application for a tourist enterprise licence shall be as specified in item 1;
  - (b) the application for the variation of the terms of a tourist enterprise licence shall be as specified in item 3;
  - (c) the application for the renewal of a tourist enterprise licence shall be as specified in item 5:

- (d) the issue of a letter of intent shall be as specified in item 7;
- (e) the issue of a duplicate tourist enterprise licence or tourist accommodation certificate shall be as specified in item 8 or 9, respectively,

of the First Schedule.

- **5.** For the purpose of sections 25A(5) and 26(6) and (7) of the Act, the appropriate fee shall be as specified in the Second Schedule.
- **6.** For the purpose of section 121 of the Act, the fee for the issue of a duplicate tourist enterprise licence and tourist accommodation certificate shall be as specified in items 8 and 9, respectively, of the First Schedule.
- 7. The Tourism Authority (Tourist Enterprise Licence Fees) Regulations 2007 are revoked.
- **8.** These regulations shall come into operation on 1 January 2016. Made by the Minister on 1 December 2015.
