THE WASTE WATER MANAGEMENT AUTHORITY ACT

**Regulations made by the Minister under section 47 of the Waste Water Management
Authority Act**

- 1.** These regulations may be cited as the **Waste Water (Miscellaneous Waste Water Services) (Fees) (Amendment) Regulations 2022**.
- 2.** In these regulations —
“principal regulations” means the Waste Water (Miscellaneous Waste Water Services) (Fees) Regulations 2012.
- 3.** The First Schedule to the principal regulations is revoked and replaced by the First Schedule set out in the Schedule to these regulations.
- 4.** These regulations shall come into operation on 21 November 2022.

(d) lot no. 21 and every subsequent	16,000	per lot
3. Clearing waste water blockage within industrial, commercial and public premises in sewered areas, where the blockage occurs within a distance of—		
(a) not more than 10 kilometres	2,500	per intervention
(b) more than 10 kilometres	5,000	per intervention
4. Attendance to meetings and site visits convened by private developers	3,000	per visit
5. Witnessing percolation	3,000	per test
6. Verification of design of sewers, treatment plants and disposal systems		
(1) Verification of design of pumping stations in property development projects, in respect of —		
(a) design flows not exceeding 100 m ³ per day	20,000	per application

(b) design flows of not less than 100 m ³ per day nor more than 300 m ³ per day	30,000	per application
(c) design flows exceeding 300 m ³ per day	50,000	per application
(2) Verification of design treatment plant in property development projects —		
(a) design flows not exceeding 10 m ³ per day	10,000	per application
(b) design flows of not less than 10 m ³ per day nor more than 100 m ³ per day	20,000	per application
(c) design flows of not less than 100 m ³ per day nor more than 300 m ³ per day	30,000	per application
(d) design flows exceeding 300 m ³ per day	50,000	per application
