PROMULGATION OF ACT OF PARLIAMENT

The following Act which has been passed by the Parliament and signed by the President in terms of the Namibian Constitution is hereby published in terms of Article 56 of that Constitution.

ACT

To amend the Allied Health Services Professions Act, 1993, Medical and Dental Professions Act, 1993, Social and Social Auxiliary Professions Act, 1993, Pharmacy Professions, 1993 and the Nursing Professions Act, 1993 so as to extend the tenure of office of members of the various Boards.

BE IT ENACTED by the Parliament of the Republic of Namibia as follows:-

Amendment of section 5 of Act No. 20 of 1993, as amended by section 2 of Act No. 19 of 1994 and section 1 of Act No. 15 of 1998

1. Section 5 of the Allied Health Services Professions Act, 1993 is amended by the substitution for subsection 4A of the following subsection -

“(4A) Notwithstanding subsection (4) a person who, at the commencement of the General Law (Health Professions) Amendment Act, 2002, holds office as a member of a Board, is deemed to have been elected to office for a period of four years.”

Amendment of section 5 of Act No. 21 of 1993, as amended by section 3 of Act No. 16 of 1994 and section 1 of Act No. 9 of 1998

2. Section 5 of the Medical and Dental Professions Act, 1993 is amended by the substitution for subsection 4A of the following subsection -

“(4A) Notwithstanding subsection (4) a person who, at the commencement of the General Law (Health Professions) Amendment Act, 2002, holds office as a member of a Board, is deemed to have been elected to office for a period of four years.”

5. Section 5 of the Nursing Professions Act, 1993 is amended by the substitution for subsection 4A of the following subsection -

“(4A) Notwithstanding subsection (4) a person who, at the commencement of the General (Health Professions) Amendment Act, 2002, holds office as a member of the Board, is deemed to have been elected to office for a period of four years.”

Short title

6. This Act is called the General Law (Health Professions) Amendment Act, 2002.
